Graduation Requirements – all JDs

- All First Year Courses (30 credits total)
- 88 Academic Credits total (58 additional after first year courses completed)
- Professional Responsibility (FT students must take in their second year; PT students must take in their second or third year)
- Upper Level Writing Requirement, including Upper Level Research Requirement
- Upper Level Skills Requirement, including NYS Skills Competency Requirement
- Administrative Law requirement (menu of courses, not just “Admin Law”)
- ASAP courses if required for you
- 6 Professional Development Credits

“Normal” Credit Loads

Full-time students:

- Fall/Spring - 13-16 credits; 10-12 as underload; 17 as overload, with permission of AD; no fewer than 10
- Summer – Maximum 8 credits
- To graduate in 3 years, need to average 29 credits in each of 2L and 3L years

Part-time students:

- Fall/Spring - 9-12 credits, 8 as underload; 13 as overload, with the permission of the AD; no fewer than 8
- Summer – Maximum 6 credits
- To graduate in 4 years, need average of 11 credits per semester, unless take summer credits

Aim for Balance

We strongly recommend you sign up for courses that balance the following categories:

- Progress towards meeting graduation requirements
- Courses that will help you succeed on the bar exam
- Courses that will help you prepare to be a competent and ethical practitioner
- Courses that interest you
- Courses that will help you pursue an Advanced Certificate or Path to Practice (optional)

**MANY CLASSES SATISFY MORE THAN ONE CATEGORY
AT THE SAME TIME**

Frequency of Course Offerings

- Professional Responsibility (PR): 4 sections in fall; 1 section in spring
- Evidence, Criminal Procedure-Investigations, Corporations, Sales and Wills are offered every semester
- Courses required for one of the three Advanced Certificates offered at least once per year
- Most other bar and core courses offered once per year; some upper level specialty courses offered every other year

Office of Academic Success

- ASAP Program: For all students below 2.8 GPA after second or any subsequent semester
 - 2L Year – must take Principles of Legal Analysis
 - 3L Year – must take designated bar preparation courses; likely 3 credits in fall and 2 credits in spring [if graduating in spring]

Admission to the Bar (New York)

- Uniform Bar Examination (UBE)
 - Registration period: Oct 1-31 for Feb Bar; Mar 1-31 for July Bar
 - Applications for test accommodations must be received in the Board's office no later than October 31st for the February exam and March 31st for the July exam
- New York Law Course
 - Approximately 17 hours of video lectures
 - Complete this within 1 year before or 3 years after passing the UBE
- New York Law Exam
 - Typically offered 3 times per year (April, September, December)
 - Complete this within 1 year before or 3 years after passing the UBE
- Multistate Professional Responsibility Exam
 - Typically offered 3 times per year (March, August, November)
 - Score is valid for 3 years in New York
- 50 Hour Pro Bono Requirement
- Character and Fitness

Uniform Bar Examination (UBE)

- The UBE consists of the Multistate Bar Examination (MBE), the Multistate Essay Examination (MEE) and Multistate Performance Test (MPT).
- Offered through February 2028 in select states

NextGen Bar Exam

- Unclear when/if NY or NJ will adopt
- Connecticut adopted for 2026
- Covers MBE topics plus Corporations [no Conflicts]
- Family Law added as subject July 2028

Content:

- MBE-like multiple-choice questions
- MPT-like short answer questions integrating doctrine and lawyering skills
- No long essays; a little less memorization
- 1.5 days instead of 2 days
- Possibility that NY will expand its NYLE to half-day
