Contract Type	Description
Artistic Performance Agreement	Agreement to provide musical or other artistic performances on campus (musical, theatrical, dance, etc.).
Catering Agreement (off-site)	An agreement with a caterer that will provide catering services off-site (i.e. restaurant, hotel).
Catering Agreement (on-site)	An agreement with a caterer that will provide catering services on-site.
Clinical Affiliation Agreement	Agreement with an external site for Pace student clinical training .
Computer Software Purchase and/or Maintenance Agreement	Agreement to purchase/lease and/or maintain computer software.
Computer Hardware Purchase and/or Maintenance Agreement	Agreement to purchase/lease and/or maintain computer hardware.
Construction/Architectural/Engineerin g Service Agreement	Agreement with architects, engineers, construction managers, contractors, construction subcontractors or other construction-related consultants.
Consultant/Vendor Services Agreement	Agreement used when an individual or company provides non-employee services to Pace.
Co-op/Internship/Volunteer/Trainee Agreement	Agreement for student co-op/internship/volunteer/trainee opportunities (at an external site or at Pace).
Education Affiliation Agreement	Agreement with other domestic or foreign educational entities including, but not limited to:  1. Articulation Agreements (credits are transferable to Pace); and  2. Memorandums Of Understanding for: a) Joint-degree/Non-degree/Degree programs; b) Research; c) Student Study Opportunities (unilateral and bilateral); and d) Faculty Exchanges.
Educational Training Services by Pace	Agreement for Pace to provide customized training for government or corporate employees, clients, or designees.
Equipment Purchase/Leasing/ Financing/Maintenance Agreement	Agreement to provide maintenance services for equipment; Purchase or lease of equipment, supplies, etc., not covered by Purchase Order.
Equipment Purchase/Leasing/ Financing/Maintenance Agreement	Agreement to conduct a Pace-sponsored event at an off-campus location. (Includes agreements to reserve and/or purchase a block of rooms in a hotel.)
Event Co-sponsorship Agreement	Agreement with an individual or company outlining terms of sponsorship for an event with Pace department or unit thereof.
Facility Use Agreement (Agreement for the Use of University Facilities)	Agreement to permit non-Pace entities to use Pace facilities.
Grant Agreement/Sponsored Research and other Activity Agreement	Agreements with government and private grant funders for research and other activities and agreements between the University and its grant-funded subcontractors.
Location Filming Agreement	Agreement granting permission to film or record within Pace facilities.
Management Agreement	Agreement with a vendor for the management of University facilities or services (i.e. security, food service, bookstore, cleaning, etc.).
Material Transfer Agreement	Agreement that governs the transfer of tangible research materials between Pace and a third party.
Model Release	Agreement with an individual to pose for art students in the Fine Arts Program.
Non-Disclosure Agreement	Agreement between Pace and an outside party governing confidentiality and nondisclosure of proprietary, personally-identifiable, or other material.
Publishing Agreement	Agreement for Pace Press to publish books and other materials.
Speaker Agreement	Agreement between Pace and a speaker at a Pace-sponsored event/lecture.
Sponsorship/Branding Agreement	Athletic or other University program sponsorship.
Study Abroad	Agreements with travel agencies, tour operators, academic tour study abroad companies, direct agreements with foreign universities, and exchange agreements with foreign universities. Governs short-term student travel arrangements related to student courses or semester or longer study abroad arrangements.
Waivers and Releases for Participation in University Activities	Release of claims against the University arising from participation in University activities.
Web Service Licensing Agreement	Agreement to purchase and/or obtain a subscription to use web-based databases or other services.
Work Study Agreement	Under federal work study program, agreement with a third party to place Pace student and pay student.
